REQUIRED SUPPORTING DOCUMENTATION FOR REPOSSESSION AFFIDAVIT

The repossessing lender must provide the following documentation for the Repossession Affidavit to be approved:

- A. Properly completed Repossession Affidavit.
- B. Actual or certified copy of chattel mortgage, conditional sales contract, or other type security agreement.

NOTE: Contract must indicate the vehicle has been pledged as collateral and list as Collateral and list a complete description of the unit along with a vehicle Identification number (VIN).

- C. Lien release copies #3 and #4, or notarized lien satisfied statement. If more than one (1) lien holder, the following is also required:
 - a. A copy of a letter from the repossessing lender notifying the second lien holder of the intent to repossess.
 - i. Letter must be dated at least ten (10) days prior to the date the repossession affidavit is processed by the Kaw Nation Tax Commission.
 - ii. The Post Office receipt and the return receipt (green card) signed by the second lien holder is required as proof of mailing.
 - b. If the second lien holder is making an application for a repossession title, copy #3 and copy #4 of the lien releases from the first lien holder are required.
- D. Insurance Security Verification form reflecting all required information outlined in the General Revenue and Taxation Act of 1994 unless the re-possessor is exempt from the insurance verification requirements.
